LWVGB PROVIDES LOCAL CANDIDATE AND RACE INFORMATION ON VOTE411.org

During this 2020 election season, local races and candidates in the Greater Birmingham area are included for the first time on <u>VOTE411.org</u>. VOTE411 is a "one-stop-shop" online voter guide with information about national, state, and <u>local</u> elections. It is a simple, accessible tool that provides candidate information, a voter registration tool, polling place information, and other helpful election information for all voters nationwide.



LWVGB provides this premier voter resource to the citizens of Jefferson County, Shelby County, and beyond. In all, we have invited 113 candidates in 39 races to participate in VOTE411. At this time, 56% of the candidates have responded and entered information. We are receiving more candidate input daily and expect this participation rate to rise.

The candidates are invited to post their contact information, social media accounts, photo, and answer questions. The questions address such topics as the candidate's

interests and reasons for running, qualifications, and positions on issues of concern to the community. Each candidate provides her or his own information which is posted verbatim on VOTE411.org. In addition to the local races and candidates covered by LWVGB, LWVAL posts state-wide races and candidates, and LWVUS posts information about the presidential candidates. By simply entering her or his address, one can view the candidates on one's own ballot - in local, state and national races. The voter can then compare the candidates in any race, side-by-side.

LWVGB is covering a wide range of races in the VOTE411 voter guide. The races covered in the Presidential Party Primary Election (March 3rd) and Party Primary Runoff Election (July 14th) included Circuit Court, District Court, Jefferson Co. Tax Collector, Jefferson Co. Treasurer, and four Constable races. We covered the Alabama House District 49 Special Republican Primary Election held August 4th. (There was no Democratic Primary.) That state house district includes parts of Bibb, Chilton, and Shelby Counties. The municipal elections (August 25th) in Gardendale, Homewood, Hoover, Mountain Brook, Pleasant Grove, Sylacauga (Talladega County), and Vestavia Hill are included in VOTE411. (Note: Other municipal elections in the Greater Birmingham area this year are in Adamsville, Adger, Alabaster, Brighton, Center Point, Fairfield, Fultondale, Irondale, Leeds, Trussville, Pelham, Pell City, and Springville.)

LWVGB promotes VOTE411 on the <u>League website</u> and on our social media accounts on Facebook (<u>@lwvgb</u>), Twitter (<u>@lwvg</u>) and Instagram (<u>@lwvgreaterbirmingham</u>). When you see a LWVGB social media post about VOTE411 (or any other LWVGB post!), we encourage you to like, share, repost, etc. This will heighten the visibility of VOTE411.org, encourage greater participation by the candidates, and as a result, make it possible for voters to be better informed when they go to the polls (or the mailbox).

LWVGB membership is open to anyone who is 16 years of age or older.

Dues are: Individual - \$55.00

Household - \$80.00 Student - \$15.00

Note that the dues for an additional household member have increased from \$20 to \$25, making the Household membership total \$80. Since the per-member payment to state and national is \$21, it was necessary to increase dues to cover costs.



CENTENNIAL OF SUFFRAGE

In August 1920, a raucous, boozy special session of the Tennessee legislature wrestled with the question of a Constitutional amendment to guarantee women the right to vote. The Senate passed the amendment, but the vote was close in the House. Pressures from both pro and anti-sides were intense, as 35 states had already approved it and it would take 36 of the 48 states in the Union to enshrine it in the Constitution. Harry T. Burns, who had voted against the



amendment, changed his vote and broke a tie in the House of Representatives--because of a note from his mother Febb delivered to him that day. The vote to ratify the 19th Amendment passed by one vote on August 18th. The amendment was signed by the governor on August 24th, then certified by the Secretary of State on August 26th, 1920. (NOTE: The Alabama legislature rejected the amendment on September 22nd, 1919 despite efforts by leaders such as Pattie Ruffner Jacobs of Birmingham, president of the AL Equal Suffrage Association. Alabama finally ratified the 19th Amendment on September 8th, 1953, 34 years after it became part of the U. S. Constitution.)

Many organizations have worked for almost two years to build momentum for acknowledgements of this month's centennial. However, a pandemic has forced a postponement of these events into 2021 and beyond. Nevertheless we should pause to thank those women and men who worked tirelessly for decades to secure the vote for women, and we can redouble our contemporary efforts to ensure the right to vote is not suppressed or made so difficult that many voters cannot exercise a basic right of citizenship.

It is appropriate that this centennial occurs during a season of elections at local, state, and national levels. The League is being sought out for voter education, absentee voting information, assistance in restoration of voting rights, and nonpartisan information on candidates.

LWVGB DUES ASSISTANCE FUND

This fund was instituted a year ago to ensure that anyone with an interest in joining or renewing membership in the League is not hindered by income or financial difficulty.

A member may recommend assistance on behalf of another person when permission is received from that person. As always, a member may also pay full membership dues for another person.

The terms of the assistance include:

- The member receiving assistance is asked to be involved in LWVGB activities and to contribute a minimum of \$15 for an individual membership or a minimum of \$20 toward a family membership.
- No proof of financial need is required.
- The identity of the recipient is confidential.

The fund carried over \$144.25 from last year. We anticipate a greater need this year. If you are able, please consider contributing to the Dues Assistance Fund by earmarking a donation to the General Fund at https://lwvgb.org/about/donate/.
