
PRESIDENT'S PARAGRAPHS **Leonette Slav**





GIVING TUESDAY AND THE CARES ACT

Giving Tuesday, always five days after Thanksgiving, was started in 2012 by the 92d Street Y and the United Nations Foundation. It was an attempt to balance the post-Thanksgiving consumerism of Black Friday and Cyber Monday with a day devoted to giving to nonprofits of all types. Last year Giving Tuesday contributions totaled almost \$2 billion globally. This year Giving Tuesday falls on December 1st.

Members of LWVGB have a special incentive to participate in Giving Tuesday this year, as one of our members has generously offered to provide matching funds, up to \$400, and the match will go through December 31st. So, we have the chance to add up to \$800 to our Educational Fund (which are tax deductible contributions). This will enhance our ability to do voter outreach during the 2021 Birmingham city elections and 2022 statewide races.

To contribute to the Ed Fund through either our expanded Giving Tuesday matching campaign or the suffrage 2020 fund, use this form and have your contribution doubled up to \$400. What a meaningful holiday gift this might be for the voters in



In another incentive, the CARES Act allows all taxpayers to take a charitable deduction of up to \$300 per tax return, even if not itemizing. For example, if you donate up to \$300 in cash to a qualified charitable organization like the LWVGB Educational Fund, your adjusted gross income (AGI) will be reduced by up to \$300--and you can still claim the standard deduction. As the centennial year of the ratification of the 19th Amendment comes to a close, please consider including LWVGB in your giving plans.

VOTER SERVICES REPORT

OVERVIEW OF THE LEAGUE'S PRE-ELECTION 2020 VOTER REGISTRATION EFFORTS

The Alabama Secretary of State Press Secretary Grace Newcombe reports that more people in Alabama cast their ballots in the November 3rd election than ever before in Alabama.¹ Unofficially, there were approximately 331,794 absentee ballots requested and approximately 318,692 (96% percent) of them were returned. Thanks to the League of Women Voters of Greater Birmingham's ("The League") voter services volunteers, our voter registration/voter education drives contributed to this increase in voter participation.





During this Pre-Election 2020 cycle, The League's voter service volunteers served over 1,658 citizens from August — October 19, 2020, largely by connecting with other non-profit, non-partisan organizations. At our Grace Klein Community site, alone, our weekly volunteers provided voter education handouts to an average of 130 persons, once weekly, entering the drivethrough to pick up food boxes.

October was quite a busy month with voter registration and voter education drives throughout Jefferson County! Voter Services volunteers served citizens in Greater Birmingham, Fairfield, Midfield, Bessemer, Gardendale, Alabaster, Irondale, and Hoover. There was a pool of over 18 volunteers dispatched at various locations. Some of our volunteers provided voter education literature at breweries. Others provided voter education through ZOOM forums, while some provided information at their respective churches. During this pre-election cycle, The League collaborated with Alabama Rivers Alliance, Alabama Vote!, Greater Birmingham Ministries, Inc., Zion Star Community Development, Inc., H.I.V.E., Magic City Bar Association, Alabama Lawyers Association, Upsilon Eta Omega



Chapter of Alpha Kappa Alpha Sorority, and Alabama Thrift Stores of America, Inc. in order to expand our efforts to educate and register persons to vote, Greater Birmingham Ministries provided 75 Voter Services Handbooks for distribution to citizens. Volunteers served at the Jefferson County – Birmingham and Bessemer Division locations on Saturdays when the Election Manager's office was open to receive absentee ballots or applications for absentee ballots.

LWVGB APPLIES FOR FUNDS FROM CARES ACT 2020 GRANT

The League of Women Voters of Alabama offered a CARES ACT 2020 Grant opportunity for Voter Services. The League of Women Voters, Greater Birmingham applied for a \$500 grant to purchase a tent, printer and social distancing placemats to enhance its voter services efforts.
