## Government Web Site Review

Sunshine Week was celebrated by the LWVGB with a report on a review that a Web Review team undertook. Six members of the team looked at 19 local government web sites. President Slay wrote an editorial for the Birmingham News, printed on March 13. The team, consisting of Virginia Randolph, Ida Tyre-Hyche, Amanda McGriff, Diane Marks, Don Marks, Sarah McDonald and Connie Arnwine presented the findings at the member meeting on March 15. Several members also attended local government meetings to highlight Sunshine Week, Alabama Open Meetings Law and to report on the web review, encouraging the governments to use their web sites for communication. Members who visited local governments included Virginia Randolph, Leonette Slay, Ida Tyree Hyche, Diane Marks and Cyron dys Jackson. Certificates were given to three governments for having sites that supported open government. They were Birmingham, Hoover and Vestavia Hills.

The results of the assessment revealed that one of the sites no longer had a web site on the Internet. One site had a web site but nothing was posted. Of the 17 governments with web sites 14 listed the meeting dates, times and locations for the council/commission but many did not list the meeting dates of other committees. Most of the 14 listing meetings also listed the agenda but only 8 some or all of the time posted the minutes of the council/commission meeting and rarely any other committees.

Elected officials were listed but 5 had no phone nor email address for the officials, while one had email addresses but no telephone numbers and two had telephone numbers but no email addresses for citizens to communicate with the elected officials.

Nine of the 17 web sites offered at least some information on taxes.



Public records for some items, like property tax, were available readily in a few instances on-line. Five of the 18 had current public record information and how to request public records, including contact person and process. None had the rating for Freedom of Information Act compliance with the number of requests, number filled and reasons for denials.

While a few listed requests for bids for contracts only one listed contacts but they were out of date.

Five listed audits but only one provided results for both performance and fiscal audits

Seven of the 18 indicated the specific web site manager and a couple

more indicated a company rather than a web site manager. Two dated the information so for the rest it was difficult to know if it is current.

Some have outstanding information about zoning and building codes along with the submission process. A couple allow for on-line submission and tracking of the information. A few do not have information for zoning and building or other business licenses etc.

Current budgets were displayed for six governments and they each also included the previous years' budget. Of the six, four showed payroll with positions or groups of positions indicated, the others did not. There was no listing of payments to determine details of transaction or information on how to obtain this information. The State web site does show more detail about budgets. An interesting aspect of budgets was that the larger government entities, for the most part, were the ones displaying details in the budgets. Cities that probably have fewer departments and easier budgets had no information.

Eight of the sites offer at least some transactions on-line but some of those do not indicate that they operate with a secure server or disclose the existence or non-existence of cookies and the issue of privacy. A few with transactions allow for tickets to be paid on line and little else. Two without transactions on-line did have information about privacy and the

security of the server.

Some sites had a community feel with openness for citizens and information for civic activities. Some sites were easy to navigate and others required doggedness to finally find the information.

It was an interesting task for the team and information about the local communities was learned. The group thought it would be good do this again, with some changes suggested by those who attended the Member meeting. It was suggested that an award may be given next year to the government with a site that provides the best information and an open government approach.

Senator Linda Coleman from Birmingham has filed a bill in the current Alabama Legislative Session, to further public transit in this area.

Senate Bill 357 will re-establish an authority to oversee public transportation in the Birmingham metropolitan area. This bill specifies that the

metropolitan Jefferson County area has enough existing dedicated funding income from all sources at this time, to draw down federal matching funds and establishes an authority to implement transit throughout the area. Go to

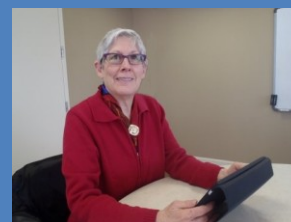
## Visiting Local Governments

### Earth Day Celebration at Birmingham Botanical Gardens

**May 1, 2011 from 1-5 PM – Volunteers needed for 1 or 2 hour shifts from 12:30 to 5:30**

On Sunday, May 1 from 1-5PM, the Birmingham Botanical Gardens will celebrate Earth Day and the League of Women Voters of Greater Birmingham will be part of the event. The Earth Day theme is A Billion Acts of Green, which has the goal of amassing one billion sustainability actions in advance of the global Earth Summit in Rio in 2012. With over 45 million actions already recorded, this largest-ever environmental service project is working to show that change can happen when individuals join in taking action.

We will have laptops to access the easy-to-use online registration tool at [act.earthday.org](http://act.earthday.org) so those who choose to can register an Act of Green - large or small. Simple individual gestures like riding a bike instead of driving, washing laundry in cold water or larger commitments like a home weatherization project or investing in energy-efficient appliances are all welcomed. This would be a good time to calculate your ecological footprint using the interactive Earth Day Network simulation.

A fun event for children will be creating carbon dioxide in a balloon by mixing vinegar and baking soda and snuffing out a candle with the gas. This provides a brief window of opportunity to talk about CO2 and its importance in warming the planet. We also plan simple crafts for youngsters.

Senator Arthur Orr sponsored SB 112, a constitutional amendment which will eliminate the racist language from our Constitution. It has passed through committee with a unanimous vote and is now in the Senate Rules Committee (above). Contact members of the Senate Rules Committee and ask them to support SB112.

Rep. Mike Hill has sponsored HB 181, a constitutional amendment which will allow limited home rule to counties that vote to accept it. This bill will not allow the counties to raise taxes or fees. Senator Jabo Waggoner plans to sponsor a similar bill but has not filed it yet.
