Voter Registration

A qualified voter is a U.S. citizen at least 18 years of age, a resident of Alabama and registered at a current home address. If you have moved or have not voted in 4 years, you will need to complete a voter registration form to update your registered status.

Register to vote at least 10 days before an election date.

Know your social security number (or the registrar will assign you a number) and the address of your last place of registration (if applicable)

Absentee Ballot

Apply in person or in writing at the county court house at least five days before an election date. You may also download a copy of the absentee ballot request form at www.sos.state.al.us which may be mailed to the Probate Clerk at the County Courthouse and which must be received at least five days before an election date.
